ISO 9001 - 2015 is suitable for any organization - large, medium or small scale from any sector.

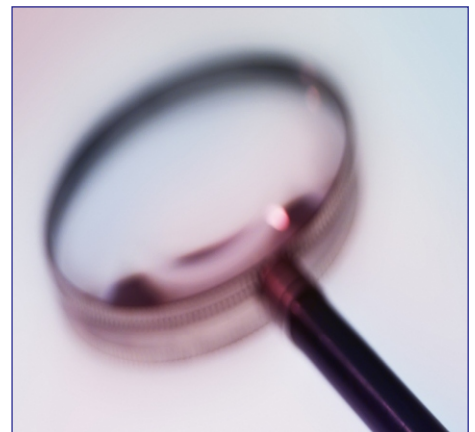
QMS -An Overview ?
