#### Why do I need SHIP BREAKING / SHIP RECYCLING ?

##### Why “SHIP BREAKING / SHIP RECYCLING” Industry needs this International Standard?

- Ø This International standard has come into effect from 15.03.2009, in response to demand from “SHIP RECYCLING/ SHIP BREAKING INDUSTRY” in accordance with the rules given in the ISO/IEC, Directives, Part-2.
- Ø ISO 30000:2009 International Standard Provides for “SHIPS & MARINE TECHNOLOGY-SHIP RECYCLING MANAGEMENT SYSTEMS - Specifications for Management systems for Safe & Environmentally sound ship recycling facilities”.



- Ø The specifications mainly contain Health, Safety, Welfare/Social Amenities and Environmental protection requirements as per IMO Convention.
- Ø This one standard, now combines integrated management standards (ISO 9001, ISO 14001 & OHSAS 18001) applicable to ship recycling (ship Breaking) Industry.
- Ø Indian Maritime Boards may impose this standard as **obligatory** on the ship recycling organizations, under their respective jurisdictions.
