What is Emergency Response & Disaster Management Plan (ERDMP):-

“Emergency” means a situation or scenario which has the potential to cause serious danger to persons, environment or damage to property and which tends to cause disruption inside and / or outside the premises and may require the help of outside resources.

Disaster management plan“ means a well coordinated, comprehensive response plan to contain loss of life, property, environment and provide speedy and effective recovery by making the most effective use of available resources in case of a disaster

Why ERDMP audit required.

Mandatory requirement of PNGRB :

G.S.R. 39(E) Petroleum and Natural Gas Regulatory Board (Codes of Practices for Emergency Response and Disaster Management Plan (ERDMP)) Regulations, 2008.

Applicability of Regulation

- Ø Hydrocarbons Processing Installation (Refinery, Gas processing, LNG Regasification Installations etc.
- Ø Pipeline such as Natural Gas, Propane, Butane etc.)and the hydrocarbons product which remains in gaseous state at NTP
- Ø Liquid Petroleum Product Pipeline.
- Ø Commercial petroleum storage facilities and Terminals including LNG Terminals.
- Ø Hydrocarbons gas bottling Installations having receiving, storage and handling facilities including storage for LPG, Propane and Butane.
- Ø City or local natural gas distribution facilities.
- Ø Dispensing stations and POL retail outlets.
- Ø Transportation of Petroleum products by Road Any other installation as may be notified by the Board from time to time.

Who has approved ICS for conducting ERDMP audit ?

- Ø Conformity Assessment Body as per ISO/IEC 1720 –Certified by NABCB
- Ø Petroleum and Natural Gas Regulatory Board (PNGRB)
- Ø Quality Council of India (QCI)

Methodology of Verification & certification system

- Ø Review of Emergency Response & Disaster Management Plan to identify gaps in documentation.
- Ø Site visit to verify ERDMP implementation.
- Ø Identify the gaps in implementation and issuing corrective action requests for gaps identified.
- Ø Verification of corrective actions taken on gaps identified in documentation & implementation Recommendation for certification.
