PRODUCT CERTIFICATION

Why do I need Product Certification ?



The marking with a Standard Mark of a Certification body on a product is known as Product Certification. At present, product certification scheme is being used by various organizations globally as a tool to convince the consumer about the quality of their product / services with the tag of third party assurance.

Product must comply with the specified directive(s) and the standard. One or more 'Standards' may be applicable for the same product. Contact ICS to find out, which 'Standards' are applicable to your products.

Which products need it?

The products requiring the standard marking include toys, machinery, Electrical equipments, Electronic Equipments, Pressure Equipments, Construction Products, Gas appliances, Chemicals, Dyes, Stationary items, textile products, medical apparatus etc.

Before a manufacturer or importer is allowed to affix Standard marking on his product, there are a few steps to be undertaken by the Manufacturer / Organization.



Conformity Assessment Procedure:

Third Party Certification

- Assessment by Competent Certification body
- Manufacturer's technical file with Conformity Assessment Body's report
- Certification body issues certificate and approval mark.
- Declaration of conformity and affixing standard mark by Manufacturer.

Also, Certification Body carries out:

- Assessment to verify that the product meets all requirements of the applicable standard.
- Assessment to Users Manual with instructions (when applicable).
- Assessment to Technical File, content of which shows that the product meets all applicable requirements.

How to go for Product

General steps for getting Standard Mark Approvals are:

- Identification of applicable standards
- Choose the appropriate assessment path
- Preparation of a technical file including design, drawing, technical specification, user manual and service manual, as applicable.
- Perform compliance testing of products in NABL Accredited Laboratory as per requirements of Standard/ OAP / Scheme approved by Certification Body.
- Appointment of Technical Personnel (wherever applicable)
- Drawing of Declaration Of Conformity.
- Audit By Notified Body / Third Party Certification Body.
- Affixing standard mark on Product and/or product Packaging.



Benefits of Product Certification

- Enhances product credibility
- Leads to improved sales and greater customer satisfaction
- Ensures product compliance with the essential requirements of the relevant standard
- Permits the withdrawal of the non conforming products by enforcement authorities
- Reduces rejections, liability claims, timescale and costs.
- Promotes public health and safety
- Enhances organization's image
