Regulatory authorities are now stepped up with new ways to reduce the environmental impact and potential hazards of wastes from electrical and electronic equipments.

The European union directive on the Restriction of Hazardous Substances (RoHS) holds electrical and electronic equipment companies directly responsible for the chemical compliance of their products. This means that concentration levels of Heavy Metals like Lead (Pb), Cadmium (Cd), Mercury (Hg), Chromium (Cr +6) and Polybrominated bi phenyls (PBBs), Polybrominated diphenyl Ethers (PBDEs) on electrical and Electronic equipments should not go beyond 0.1%/0.01%.

This means that all products must conform to European Directives as per Annexure VI (EU Declaration of conformity) under self certification, provide extensive compliance of technical documentation, and ensure that electrical and electronic products sold in the EU do not contain lead, Cadmium, mercury, hexavalent chromium, polybrominated biphenyls (PBBs), and polybrominated diphenyl ethers (PBDEs) above the legal threshold. Manufacturers, owners, retailers, and importers are alike need to ensure that their products comply RoHS in order to be distributed and sold in the EU.
