

On August 16, 2004, we received accreditation from NABCB for QMS ISO 9001 and EMS 14001, as well as for IB (Inspection Body) ISO 17020. In April 2017, we achieved accreditation for MDQMS ISO 13485.

Additionally, on May 14, 2009, we were accredited for HACCP by DAC, now known as EIAC.

We also received approval from PNGRB as a TPI agency on April 4, 2011, and for the certification of ERDMP on October 12, 2011.

#### **New Accreditations and Approvals**

In our quest for excellence, we obtained approval from FSSAI for Third-Party Audits for FBOs on 28th August, 2018 and received recognition from CDSCO as a notified body for MDR-2017 audits on 22nd May, 2020.

By 2024, we had certified over 12,000 clients for ISO certification and numerous clients for third-party inspections. Our workforce expanded to 750 employees across 27 branches, managing numerous third-party inspection and certification activities.


